RE: Letter of Support for Indian River State College (IRSC) - Indiantown Workforce Charter High School – HB 3175 | Section 197 in HB 5001

Dear Governor DeSantis:

On behalf of the Indiantown Village Council, I respectfully seek your favorable consideration of \$5 million in the 2022-23 General Appropriations Act for the purposes of establishing a Workforce Charter High School in Indiantown, Florida.

The Village of Indiantown is an underserved community with no high school in its service area, poor graduation rates, and little opportunity for career and workforce training. IRSC is committed to addressing this need by creating a charter high school focused on the development of workforce skills.

Through a private donation of \$10 million, with additional commitments pledged, IRSC plans to erect the facility on land leased by Martin County in a Qualified Opportunity Zone (QOZ). IRSC has committed a minimum of \$1 million from its Foundation, and Martin County has committed \$1.5 million to bring infrastructure improvements up to the property. The \$5 million appropriation included in the budget will address much-needed on and off site improvements on the leased property, allowing IRSC to move forward with construction.

This project is highly supported by IRSC, Martin County, Indiantown, and businesses across the Treasure Coast. It will bring a partner campus to IRSC's respected Clark Advanced Learning Center, create new education and training opportunities in a vastly underserved area, support educational gains and economic/business development efforts, and most importantly, accomplish all of the above through mainly private dollars.




Overall, 284 incidents in Feb and Mar 2022. Incidents ranged from 1-12 a day with the average being 4.8 per day.



B. Incident by Day of the Week



2021 real estate: Indiantown saw largest increase in home sales, prices in Martin County

INDIANTOWN — Martin County's newest municipality hasn't been spared from the onslaught of out-of-towners moving to the area.

The Village of Indiantown, and surrounding properties in its 34956 ZIP code, saw the largest increase in both single-family home sales and average sale price in Martin County last year.

Residential, single-family home sales increased by about 81% within the village limits when compared to 2020, with 40 closed sales, according to property appraiser data. Moreover, properties in the 34956 ZIP code rose 127%, seeing 59 total sales.

Prices jumped, too, with the area overall seeing a roughly 57% increase in its average sale price. One property on Southwest Kanner Highway sold for nearly \$1.6 million.
