- The replacement of the old water meters with radio read meters has commenced. This will be an ongoing project for several months.
- Staff are in the process of cleaning up around the Sewer Plant and Water Plant (i.e., Removal of surplus equipment & junk removal and lawn maintenance)
- Staff are continuing planning for the Water and Wastewater Plant upgrades with Kimley-Horn and Associates, Holtz Consulting Engineers, and CAPTEC Engineering.
- Staff are in the process of repairing all the automatic flushers throughout the water distribution system, which will improve water quality at the dead ends where they have been placed.
- Staff are on schedule with the new development that is coming to the Village. With Tractor Supply now being

open and Indiantown Bio-Medical having started their site work, the utilities are the first items to be installed along with the storm drainage. Indiantown Bio-Medical is looping a water main to increase water pressure on a dead end main, which will increase fire flow for that area. Tractor Supply is also extending a water main; however, it will not have any effect until further growth extends it to the west. It will most likely be the Terra Lago Project that will pick it up.

 Staff are beginning to have planning conversations with the Terra Lago Developers and engineers, regarding the utilities.

Dear Governor DeSantis:

On behalf of the Indiantown Village Council, I respectfully seek your favorable consideration of \$5 million in the 2022-23 General Appropriations Act for the purposes of establishing a Workforce Charter High School in Indiantown, Florida.

The Village of Indiantown is an underserved community with no high school in its service area, poor graduation rates, and little opportunity for career and workforce training. IRSC is committed to addressing this need by creating a charter high school focused on the development of workforce skills.

Through a private donation of \$10 million, with additional commitments pledged, IRSC plans to erect the facility on land leased by Martin County in a Qualified Opportunity Zone (QOZ). IRSC has committed a minimum of \$1 million from its Foundation, and Martin County has committed \$1.5 million to bring infrastructure improvements up to the property. The \$5 million appropriation included in the budget will address much-needed on and off site improvements on the leased property, allowing IRSC to move forward with construction.

This project is highly supported by IRSC, Martin County, Indiantown, and businesses across the Treasure Coast. It will bring a partner campus to IRSC's respected Clark Advanced Learning Center, create new education and training opportunities in a vastly underserved area, support educational gains and economic/business development efforts, and most importantly, accomplish all of the above through mainly private dollars.
