## **VILLAGE OF INDIANTOWN PERMIT FEE SCHEDULE**

*ALL CHECKS PAYABLE TO THE VILLAGE OF INDIANTOWN*

### **SINGLE FAMILY & DUPLEX FEES:**

#### **Permit Submittal Fees:**

1. Plan Review Fee – ½ of the building fee (non-refundable after review)

#### **Permit Issuance Fees:**

1. Processing/Site Compliance Fee – \$200.00
2. Building Permit Fee less plan review fee payment.  
This fee includes the cost of all sub-permits (electric, plumbing, a/c, etc) pulled under this permit).
3. County Impact Fees – click [here](#).
4. State of Florida DCA Surcharge – 1.5% of total building fee or \$2.00, whichever is greater
5. State of Florida DBPR– 1.0% of total building fee or \$2.00, whichever is greater
6. Road Assessment – .001 (.1%) of construction value

## **SINGLE FAMILY & DUPLEX ADDITION FEES:**

### **If construction value is \$50,000 or greater:**

#### **Permit Submittal Fees:**

1. Plan Review Fee – ½ of the building fee (non-refundable after review)

#### **Permit Issuance Fees:**

1. Building Permit Fee – .7% (.007) of Construction Value  
This fee includes the cost of all sub-permits (electric, plumbing, a/c, etc) pulled under this permit).
1. State of Florida DCA – 1.5% of total building fee or \$2.00, whichever is greater
2. State of Florida DBPR – 1.0% of total building fee or \$2.00, whichever is greater
3. Road Assessment – .001 (.1%) of construction value

### **If construction value is less than \$50,000:**

#### **Permit Submittal Fees:**

1. Plan Review Fee – ½ of building permit fee (non-refundable after review)

#### **Permit Issuance Fees:**

1. Building Permit Fee (\$89.50 per required inspection) less plan review payment
2. State of Florida DCA – 1.5% of total building fee or \$2.00, whichever is greater
3. State of Florida DBPR – 1.0% of total building fee or \$2.00, whichever is greater
4. Road Assessment – .001 (.1%) of construction value

## **COMMERCIAL FEES:**

### **If construction value is greater than \$50,000:**

#### **Permit Submittal Fees:**

1. Plan Review Fee – ½ of the building fee (non-refundable after review)

#### **Permit Issuance Fees:**

2. Processing/Site Compliance Fee - \$200.00 (refundable)
3. Building Permit Fee – .7% (.007) of Construction Value  
This fee includes the cost of all sub-permits (electric, plumbing, a/c, etc) pulled under this permit).
4. Impact Fees(if applicable) – click [here](#).

5. State of Florida DCA (Radon) Surcharge – 1.5% of total building fee or \$2.00, whichever is greater
6. State of Florida DBPR – 1.0% of total building fee or \$2.00, whichever is greater

### **If construction value is less than \$50,000:**

#### **Permit Submittal Fees:**

1. Plan review fee – ½ of building permit fee (non-refundable after review)

#### **Permit Issuance Fees:**

1. Building Permit Fee – \$.89.50 per required inspection  
This fee includes the cost of all sub-permits (electric, plumbing, a/c, etc) pulled under this permit).

3. State of Florida DCA (Radon) Surcharge – 1.5% of total building fee or \$2.00, whichever is greater
4. State of Florida DBPR – 1.0% of total building fee or \$2.00, whichever is greater

6. **Fire Prevention**

Fees for fire prevention related services

The fees charges will either be the same as those currently charged by Martin County Fire-Rescue, or shall be charged directly by Martin County Fire-Rescue for all services provided by the County in relation to fire prevention plan review, inspections and investigations are hereby established and shall be charged and collected.

## RESIDENTIAL ACCESSORY BUILDING PERMIT FEES

Plan review fee of ½ of the building fee will be collected at time of submittal. The remaining balance of the permit fee will be collected at time of issuance. In addition to the building fee, a road assessment fee is charged which is .001 of the construction value or minimum fee of \$3.00, as well as a State surcharge fees of 2.5% of the permit fee or \$4.00, whichever is greater.
